# Agenda item 5 Approval of New Draft Legalised Constitution

- August 2004 29th ICNDT meeting, the proposal for the Executive Committee to prepare proposal for Incorporation was unanimously approved.
- November 2004 Executive Committee The process began with the selection of the country of incorporation –Vienna Austria and collection of required documentation etc.
- March 2005 PGP Committee Business plan presented to PGP
- February 2006 PGP Committee Presented with draft of proposed Constitution draft to be sent to ICNDT members for comments
- Positive agreement from 9 countries, comments from 6 countries
- May 2006 draft modified taking account of comments
- June 21,2006 final version of constitution sent for postal ballot.
- August 30 2006, deadline for voting
- 32 votes received, all positive. (one request for delay to allow further consideration).

## Legal Incorporation of ICNDT: motion for approval

- 1. The members of the International Committee for NDT authorise D Marshall, M Farley, G Aufricht and R Link of the Executive Committee of ICNDT to proceed with the foundation of ICNDT as a non-profit Association under Austrian law, registered in Vienna, on the basis of the draft Constitution dated 16 May 2006.
- 2. Further refinements to the Constitution will be proposed by the ICNDT membership up to the end of 2007 to produce a final Legalised version.
- 3. The final new Legalised Constitution will be adopted ahead of the Shanghai ICNDT meeting following a six month period as per clause 18.1 of the previous Constitution
- 4. The first General Assembly of the new legally incorporated association will be held in Shanghai during the 17th WCNDT 2008.
